IX. PUBLIC COMMENT

Benny Reed – Discussed his feelings regarding taxes and water rates. He thanked the town for sponsoring the Veterans Day and Flag Day ceremony for several years stating their importance not just for the citizens of Gate City, but for the Americans. He expressed is dismay regarding the lack of people coming out to stand up for the recognition of veterans and suggests more advertising to get more people to attend.

Mayor Perry closed the public comment session at 6:39 P.M. and opened the consent agenda session.

- **C.** <u>Codification Committee/Property Maintenance</u> Council Member, W. W. Ross, Jr. informed Council of his and Cotton Robert's meeting to amend Ordinance, Chapter 15.

- **D.** <u>Police Department Report</u> Council Member, R. Cassell, stated it was nice to have the additional information and thanked the responsible party for the good report.
- **E.** <u>Council Reports</u> Council Member, W. W. Ross, Jr., discussed glitches regarding completion of projects, receipt of his mail, check-in problem at VML conference, Job Core, and handrails. Council Members, R. Richards, R. Cassell and W. Salyers had no comments under Council Reports.
- **F.** <u>Economic Development Committee</u> Town Manager, G. Jones, informed Council they have met a couple times and discussed the Christmas Open House and ways to market businesses in town.
- **G.** <u>Historical Committee</u> No comments.
- **H.** <u>Manager</u>- Town Manager, G. Jones, goes over his report as presented in the Council packet and explains in further detail regarding the handrails and accessibility of wheelchairs at Bank of America area, razing the old theater building, increase to water rates, sidewalk improvement project and budget.
- **I.** <u>Park Committee</u> Council Member, R. Richards, informed Council they met and discussed the splash pad. She asked Acting Police Chief, S. Fink, about the cameras at Grogan Park, if they were still up. Officer Find responded he thought they were, but not sure and explained another camera system that has not been installed for some reason. Council Member, R. Richards, asked if there have been other incidents of vandalism with Acting Police Chief, S. Fink, responding no.

Acting Police Chief, S. Fink, agreed stating a traffic light would reduce individuals who are running the stop sign. Council suggested it be run past VDOT again.

XII. UNFINISHED BUSINESS

• <u>Discussion of Cigarette Tax by Jim Addington, Terry Frazier, and Claude Williams</u>

Jim Addington represented the Quik Stop Markets in Gate City. He discussed proposed cigarette tax, cites quote from John Marshall, provided statistics regarding tobacco users, it's a competitive business, eight businesses in Gate City sells cigarette products, customers will go elsewhere, decline of business in small towns, City of Culpepper Amtrak service, need for town businesses to stay open longer, suggested to increase the business and professional business license tax. He asked Council for their consideration to not vote for the cigarette tax.

Terry Frazier agreed with Mr. Addington regarding it is a highly competitive business, the need to compete, the need to be more pro-business. He discussed the meals tax, personal property tax and agreed with increasing the business license fees. He offered his help to the town.

Claude Williams discussed his idea he presented to Council Member, A. Roberts, to use all resources available to us to work on Economic Development and use the Industrial Development Authority in Scott County of John Kilgore and his staff. He informed Council of his call to Mr. Kilgore, his request for him and his staff to work with Gate City with Mr. Kilgore's response that he would, along with inviting Mr. Kilgore to the Economic Development meeting. He discussed the assessment of the business license fees, questioned the website fees and his concern of how it would increase and help his business on U.S. 23, everyone's best interest is for the development of Gate City, and 28% of people who use tobacco products are of lower income status. He closed with his request for Council to not pass the cigarette tax in Gate City.

Mayor Perry made the remark that the Town and County does work together, but we need to concentrate on Gate City, while they have all of Scott County to concentrate on. Mayor Perry does not want the public to get the impression that the Town and County are not working together, because we are. Claude Williams discussed the topics presented at the Economic Development meeting were not items for Economic Development and suggested forming a Merchants Committee for the main street businesses. Jim Addington discussed a survey done by the U.S. Postal Service from Biznet. Council Member, W. W. Ross, Jr., discussed his attendance at the VML Conference and topics discussed, specifically identifying where the town begins with the use of signs.

• <u>Decision regarding Amendment to Chapter 6, Section 6.6 Ordinance for Adoption of a</u> Cigarette Tax

Council Member, R. Richards, asked how much revenue the town would lose with Mr. Addington replying the national average would be 25% of tobacco business sales over a 1½ years. Council Member, R. Richard,s asked if the city would make money with Town Manager, G. Jones, informing Council of his research and his contact with other towns that imposed the cigarette tax showed no loss to business. Council Member, W. Salyers, expressed his concern of the towns that were looked at are not as close to the state line and Weber City and would prefer to keep the business here. Council Member, W. W. Ross, Jr., states if other cities close to Gate City do not impose the Cigarette tax it will hurt Gate City.

- <u>Fire Department to discuss the fire alarm/siren</u> No one, representing the Fire Department, was in attendance of the meeting.

Jones, informed Council of Economic Development discussion regarding the Police Dept. building located on Jackson Street. Currently, the building is vacant and their idea of it being a good location for the Scott County Historic Society, along with a possible visitor center. Currently, the Historic Society does not have a designated building, working out of one room at the library and this being an avenue for the Society to have their own building, be visible and to help bring traffic into town. Asked Council to entertain donating the building with clause if they vacate the building it would revert back to the town. Stated they have resources per their designation to rebuild the building and make it beneficial to all. Council discussed placing conditions on the deed with Town Attorney, M. Brooks, suggesting a lease.

Approval to accept reclassification of Town of Gate City Water Plant from Class II to Class III. – Town Manager, G. Jones, explained the different classes and requirements for each class, the advantages to reduce training requirements to 1 ½ years for a Class III Operator, versus 4 ½ - 5 years for Class II Operator, explained the water demand, his request to the Virginia Department of Health to entertain the idea to drop our classification to a Class III. He stated their approach would be to change the treatment process by a slim margin to 495,000 gallon a day treatment plant, which would allow us to operate as a Class III plant and it would not affect our loans. It is basically rewording it to get below the 500,000 gallons.
