#### **GATE CITY PLANNING COMMISSION**

## A) **ZONING ADMINISTRATOR**:

Mr. Jones reported that the Scott County Sherriff's Office, which will be moving into the former County Office Building on the lower level of the Lonesome Pine Regional Library, has requested a second entrance, from Water Street, into the parking area serving the office. Currently, the parking area is surrounding by fencing limiting access and egress to only one space off Library Avenue. The water conveyance draining from the parking lot toward Water Street will not be affected by the construction of the new exit.

V-DOTS's change to the parking slot markings on Jackson Street is still in the design stages.

A recent visit from a V-DOT engineer, who specializes in cross-walks, informed Mr. Jones that the cross-walk islands are on the wrong side of the actual cross walks. The islands should be in front of the cross hatched walking area. He also stated that some of the handicapped parking spaces will be relocated closer to the handicapped ramps and that the crosswalk at the junction of Kane and Jackson Street will be removed.

Mr. Jones will order five picnic tables from the Dept. of Corrections. Three will be placed at Gateway

Park and two at the new dog park.

## B) TOWN COUNCIL REPRESENTATIVE MEMBER:

Roger Cassell has examined the original solar lighting in the information kiosk at Gateway Park. His recommendation is to contact the company who designed the original set-up and determine the cost of having the same company repair the light.

Mr. Cassell has consulted an AEP representative to discuss future convenience and security lighting for Gateway Park, to include nighttime lighting of the LOVE sign.

He also suggested that the second Old King Ford property, at the intersection of US Hwy 23-N and Filter Plant Road is not being maintained by V-DOT and might eventually be brought under Gate City's control.

Mr. Jones told the Commission that V-DOT may be planning to construct a left turn lane at that site.

Gate City Frontier will actively begin the restoration of the Gate City Theater as funds become available.
