# **GATE CITY PLANNING COMMISSION**

The regular monthly meeting of the Gate City Planning Commission was held Tuesday, June 7, 2016 at Gate City Town Hall at 6:00 pm.

# **CALL TO ORDER:**

Chairman Delany Herron, called the meeting to order at 6:02 pm and asked the secretary to call the roll.

### **PUBLIC EXPRESSION:**

Mark Freeman: Mr. Freeman presented architectural drawings of the proposed developments of the Kane Street property formerly known as the Daugherty Chevrolet property, and the existing Gate City Public Parking Lot.

Mr. Freeman states that when the Kane Street property is ready for development, the zoning will need to be changed from C-1 Commercial to C-2 Central Business. This is necessary to accommodate the height of the proposed structures to be erected on the property which will be in excess of 75 feet in height.

The proposed development of the existing parking lot will include an outdoor movie screen on the west end, an amphitheater and a splash pad. Both the amphitheater and the splash pad are presented as being adjacent to the railroad tracks and Little Moccasin Creek at the southeastern corner of the parking lot.

- 1) Rev. and Mrs. Lester Morlock appeared before the Commission to request that the Commission recommend that the Town provide unobstructed access to Ruth Street, in its entirety, so that they can reach property owned by them on Ruth Street. Ruth is an undeveloped street in the Estil Heights Subdivision. It has been determined that because Ruth Street was never completed by the original developers, it has never been adopted as a Town street. The Morelocks then asked if the Town would develop the street. After lengthy discussion with no action taken, it was agreed among the Commission members that Attorney Michele Brooks should meet with the Morelocks to apprise them of legal options available to them.
- 2) Due to public interest, the Gate City Planning Commission Land Use Committee met to examine a portion of undeveloped property at Grogan Park for potential use as a subscription-only fenced Dog Park. Based on the report from the Land Use Committee, copy attached:
