### LAND USE COMMITTEE REPORT

On Thursday, August 24, 2016, the Gate City Planning Commission Land Use Committee, Vickie Roberts and Jo Ann Castle met with Gate City Town Manager, Greg Jones at the site of the new Gateway Park on US 23-N.

The purpose of this meeting was to begin the on-site development of the park, beginning with determining the location for the Virginia Is For Lovers "LOVE" sign.

We first noticed that the parking area may not be large enough to permit the safe movement of vehicles in and out. This will have to be examined further at a later date.

To place the sign in the most visible location for both North and South bound travelers and in the safest site for visitors, the choice was to place the sign, centered 12-14 feet forward of the two locust trees near the middle of the plot.

Beyond that decision, we considered a place for picnic tables. In the back right corner, there are three locust trees in a triangle but sufficiently separated to allow tables to be placed near the trees in such a way as to provide some shade for users. We believe that a covered gazebo, with tables, similar to the one at Grogan Park, would fit well to the right of the LOVE sign and slightly back toward the fenced area. (Trash receptacles will be needed.)

We discussed the possibility of requesting that the information kiosk, currently located on the V-DOT traveler's rest area across from the old Gateway Restaurant property, be moved onto Gateway Park. It could be placed on the left end behind the parking area, visible to travelers and easily accessible. We examined the kiosk and determined that though it appears to be in good condition, it is not being maintained. There were no maps, brochures or leaflets. There were some very dated posters. Mr. Jones will try to determine the owner of the kiosk. (8-29-16: Vickie Roberts spoke with Pam Cox of Scott County Tourism and she is completely agreeable with our moving the information kiosk to Gateway Park).

The question arose concerning the possibility that travelers might not pull into the park but rather stop along the side of the roadway. To prevent this, Vickie Roberts suggested that split rail fencing could be installed along the roadside boundary. V-DOT might be willing to install NO PARKING signs.

Signage has not been considered but Jo Ann Castle offered the name "Gate City's GATEWAY PARK, est. 2016 printed on the oblong shaped sign used as part of the Town's logo.

Mr. Jones noted that V-DOT has plans to develop the property across from the existing V-DOT rest stop into a park-and-ride. They might consider moving the large historical signs to Gateway Park to allow V-DOT to repurpose the existing rest area. The front property boundary on the North side of Gateway Park would provide a suitable location for the signs.
