### B) TOWN COUNCIL REPRESENTATIVE MEMBER:

- 1) Gate City Town Council, at their last regular meeting, appointed Vickie Roberts to a four year term on the Gate City Planning Commission beginning January 1, 2021 and ending December 31, 2024.
- 2) Council also appointed Margaret Falin to a one year term on the Gate City Board of Zoning Appeals beginning January 1, 2021 and ending December 31, 2021.

#### C. GATE CITY TOWN ATTORNEY:

#### **UNFINISHED BUSINESS:**

- 1) Mr. Greg Jones report on progress in the Park Street Rehabilitation Project: Residential structures at 649 and 599 park Street are approved for demolition in the first phase of the Park Street Housing Rehabilitation Project. Structures and 571 and 460 Park Street are vacant which excludes them from eligibility as part of the project. Five individuals who were initially eligible for home improvements have since died. Two structures are awaiting the removal of the residents to temporary housing so that construction can begin.
- 2) The Virginia Department of Historic Resources recommended a resident of the Yuma community to begin restoration efforts on the Estil Cemetery restoration. This individual has provided an estimate on the cleaning and repair of headstones. Greg Jones has contacted a tree removal service to clear the trees and brush in the fence line surrounding the cemetery. The DHR representative also evaluated the remaining existing fence and stated that it is not indigenous to the established date of the cemetery and does not have to be replaced in similar style and materials. He suggested that it could be removed completely or replaced with whatever materials are convenient. Some headstones that may be those of military veterans might qualify for government funding for annual maintenance.

#### **NEW BUSINESS:**
