- 2) Mr. Timothy Pendergrass came before the Commission to present suggestions for restoration of the Estil Cemetery. Mr. Pendergrass has volunteered his time in recent months to mow and begin the repair of broken stones in the cemetery. Because the cemetery is on the historic register, any further changes will require approval from The Virginia Department of Historic Resources. Mr. Greg Jones will contact this agency for guidelines on historic cemetery restoration.

NEW BUSINESS:

(1) Mr. Jones presented a request from Virginia Department of Highways for the closure of Cross Street and Wilcox Street at the site of the new Park 'N Ride.

On motion by Jo Ann Castle and seconded by Margaret Falin, Planning Commission recommends that Town Council approve the application submitted by Virginia Department of Highways, for closure of Cross Street and Wilcox Street, both adjoining U. S. Hwy 23-S at the site of the proposed construction of a Park 'N' Ride.
