The regular monthly meeting of the Gate City Planning Commission was held Tuesday, November 1, 2022 at Gate City Town Hall.

CALL TO ORDER:

Chairman, Delaney Herron called the meeting to order at 6:00 pm and asked the secretary to call the roll.

UNFINISHED BUSINESS:

- 1) Mr. Roger Cassell reported that approval of Phase II funding for the Park Street Rehab Project has not yet been received. Because there has been no activity on the Park Street Rehabilitation Project Phase I and that there will be no granting of funds for Phase II for this project until Phase I is completed, Planning Commission will defer comments until a later date.
- 2) At Roger Cassell's suggestion, the 'welcome center' sign ordered for Gateway Park will be permanently attached to the existing wooden uprights to prevent atmospheric damage or theft of the sign. This change order will be forwarded to Bristol Sign for implementation.
- 3) Up-dating of C-1 and C-2 zoning requirements is tabled until the next regular meeting.
- 4) Guidelines for use of the dog park and potential bench and exercise items were presented by Vickie Roberts. Mr. Jones will check his resources for comparable pricing on these items. Ms. Roberts also presented the cover letter she has prepared to present to area veterinarians for offers of sponsorships for the dog park.
- 5) It was agreed by Commission members to ask Greg Jones to post a notice on the Town web page and to purchase an advertisement in the Scott County Virginia Star asking for suggestions for naming the new dog park. The contest should be limited by date, after which the winning name will be published.

6) Quotes have been received from Appalachian Power for the replacement of the lighting heads and/or the complete replacement of the street lights. The quotes are higher than expected and it was agreed that Mr. Jones would advertise for quotes from independent contractors.

NEW BUSINESS:

1) Commission member Margaret Falin asked how the Town can require a homeowner to clear undeveloped property. She has received a Notice of Violation because one of her neighbors has filed a complaint that she has property within his line of sight that is not mowed. Mrs. Falin is unable to perform the required yardwork personally and has been unsuccessful in hiring anyone to do the work. She also noted that a street right of way adjoining her property has not been cleared and is so overgrown that the Town backhoe was forced to drive through her yard to gain access to a water line leak. Ms. Falin was advised to refer to the Town's Property Maintenance Ordinance.
