### **UNFINISHED BUSINESS:**

- 1) Mr. Jones assured Planning Commission members that the two on-going park projects will be addressed in the proposed 2018-2019 budget.
- 2) The work trailer installed at the old train depot site on Depot Street has met and completed the implementation of all permits.
- 3) After brief discussion of HB 1258, effectively eliminating local control over the installation, operation, placement and replacement of telecommunications facilities and equipment within the city limits, Mr. Jones presented a draft letter in opposition to the passage of this bill.

#### **NEW BUSINESS:**

- 1) Mr. Jones informed the Commission that a Taco Bell Restaurant will be built on the now abandoned Pizza Hut property.
- 2) The stakes placed at Gateway Park to mark the location for placement of the historical signs being moved from the current V-DOT picnic area are on the wrong side of the proposed entrance. Mr. Jones will contact V-DOT concerning locating the signs on the north side of the entrance.

## **ITEMS NOT ON AGENDA:**

- 1) Jo Ann Castle questioned the number of properties within the Gate City Town limits that are unassigned, with no owner listed. Attorney Brooks stated that there are a few but all are small parcels generally located adjacent to or between existing developed properties. All are more than likely to be simple cases of improper property descriptions on recorded deeds.
- 2) Vickie Roberts asked for clarification on the definitions of Land Use and Capital Improvements. Generally the uses and application of real estate within the city limits is addressed by the Land Use designation. Capital Improvement is directed toward the infrastructure and long term monetary investment in construction, maintenance and services.
- 3) Delany Herron requested a list of current Board of Zoning Appeals members. Mr. Jones will provide that list.
