> Bed and Breakfast Tourist Home

3) Sec.30-150, Residential District R-3 (Manufactured Home Residence) Add Uses:

Boarding Houses Bed and Breakfast Tourist Homes

 Sec. 30-182, Commercial District C-1 Add Uses:

Bed and Breakfast

5) Sec. 30-214, Central Business District C-2 Add Uses:

Boarding Houses, with a special exception and use permit Bed and Breakfast, with a special exception and use permit
