### **GATE CITY PLANNING COMMISSION**

The regular monthly meeting of the Gate City Planning Commission was held Tuesday, June 6, 2023 at Gate City Town Hall.

## **CALL TO ORDER:**

Vice Chairman Vickie Roberts called the meeting to order at 6:07 pm and asked the secretary to call the roll.

# **PUBLIC EXPRESSION:**

Commission members reviewed an application for a Special Exception and Use Permit from Mr. Cody Ferguson to install fencing surrounding his property at 163 Eva Street, Gate City. Because Mr. Ferguson's property is located on a corner lot, his original application for a Landscape Permit was denied pursuant to Sec. 30-27. of the Zoning Ordinance.

He subsequently submitted an application for a Special Exception and Use Permit. Because line-of-sight on a corner lot is directly influenced by any obstruction on any immediately adjoining properties, Mr. Ferguson submitted pictures of six foot welded wire see-through fencing to be set six feet from the pavement edge on Eva Street.

He also submitted a signed petition from his surrounding neighbors stating that none had any objection to the installation of this type and size fencing.

Because this type of fencing will not obstruct the visibility for vehicle operators at this intersection, Motion made by Jo Ann Castle and seconded by Margaret Falin recommending that Gate City Town Council approve this permit application.
