- 2) Mr. Jones also reported that he had received a letter from a group interested in establishing a drug rehab office in Gate City. He will contact the agency and inform them that their request does not meet the requirements of Gate City's zoning ordinance.

### **ITEMS NOT ON AGENDA:**

Jo Ann Castle reported seeing that the front porch and part of the front wall of the first house on the left, behind Southern Graphics at 137 Woodland Street has collapsed. She asked what can be done to remove or mitigate the hazard produced by this development. Mr. Jones stated that the property owners have no interest in restoring this house to livable condition. Attorney Michelle Brooks informed the Commission that a permit for demolishing the structure will not be granted by the Scott County Building Inspector as long as taxes are owed on the property. She suggested that she could meet with the Board of Supervisors to find a way to solve this problem.

Gate City CDBG Housing July 12, 2021 Rehab Specialist Report

- A. <u>171 Margie St</u>- Relocation unit- have moved into house and are ready for old house to be removed.
- B. <u>639 Park St</u> Demolition contract signed with Day 3 Construction. Asbestos removal has been ordered by contractor and house demolition will start as soon as asbestos has been cleared.
- c. <u>559 Park St</u> Still looking for a suitable house for relocation or re-bidding new construction.
- D. 609 Park St- rehab ready to bid
- E. 571 Park St- rental unit- rehab ready to bid
- F. Contractors: have been in contact with Totten Construction LLC, Clamon Home Builders, and Kennedy Construction about Gate City rehabs.

<u>Totten Construction LLC</u> is pre-qualified on Gate City contractor list and indicated would bid rehabs, then 3 previous bids in another locality were approved and Totten is busy until late November.

<u>Clamon Builders</u> are a Tennessee licensed contractor with ties to Gate City and are considering getting a Virginia license to help finish this CDBG Project and possibly other CDBG jobs in their traveling radius.

<u>Kennedy Construction</u> is licensed in Virginia & Tennessee. I am speaking with David to schedule a date & time to walk through rehabs and get a price (contingent on whether the "Company" would be interested in the "small" jobs).
