II. APPROVAL OF MINUTES

III. PUBLIC COMMENT

John Poole requested that his tenants at 216 Richmond Street want sewer removed from bill. The property is not on sewer it stops short of his property approximately 150 ft. the property has a septic system. Jim Craft asked if we had looked into it. Town Manager Steve Templeton said we have looked at the property and Public Works Forman Stoney Falin also says that the property could be added to the sewer service. Town Attorney Mike Carrico suggested that Public Works Forman Stoney Falin go out to the property and access the cost to add to sewer and let them know at the next meeting.

- A. Dewey Breeding asked if all equipment has been removed from the sewer plant.
- B. Andy Miles stated that he attended the PSA board meeting and stated that the plant will be closed May 31, 2009. Town Manager Steve Templeton asked for a follow-up letter from town to DEQ stating the same. Town Manager Steve Templeton would like to be on PSA's mailing list. Town Manager Steve Templeton said he and Town Engineer Andy Miles could rotate going to the monthly PSA board meetings which are held the 2nd Tuesday of the month.

V. NEW BUSINESS

Town Manger Steve Templeton and Mayor Jenkins had requests from businesses to have their sewer bills adjusted due to freezing or busted water pipes. East End Barber shop has a water line break they have asked that the sewer portion be adjusted. Joe Maya of Chris' Dept Store has a similar request, he told Mayor Jenkins that the water went into his basement not the sewer. Cindy Coates suggested we take a 3 month average of the customer's sewer bill and adjust it accordingly. Cindy Coates also suggested we have a policy in place if this happens again.

Cindy Coates questioned the difference between December 2008 bills and February 2009 bills. Town Manager Steve Templeton stated it was because we had begun to pay our debt back and it was not shown on the December billing.
