III. NEW BUSINESS

A. Public Hearing on Proposed Sanitation Authority Budget for 2013-2014

Town Manager, G. Jones – Reviews Draft #7 and discusses the breakdown of the budget with the final projection of a \$54,084.00 deficit that will result in a rate increase of 116% that will bring it up to the revenues necessary to cover our expenditures for the next year.

Chairman/Council Member, R. Cassell – Asked if wages were taken out this year.

Town Manager, G. Jones responded no it was left alone and further explains expenditures with PSA and explains lines items with reductions. Provides Board an explanation of the bonds creating a situation (1990-A FHA Sewer Bond, 1990-B FHA Sewer Bond and 1993-A FHA Sewer Bond) that over the years were paid from our Water Fund not by the Sanitary. These items had to be moved back over.

Chairman/Council Member, R. Cassell – Informs Board of Town Manager changing the lay-out of the monthly report to understand easier.

Town Manager, G. Jones – Explains the debt ratio and it is short.

Town Attorney, M. Brooks – Questioned the proposed rate increase if it takes into consideration for any water rate increase which is currently 100% of the water with **Town Manager, G. Jones**

stating, no, it has nothing to do with the water and explains of a rate increase in the Spring of next year which will result in the sewer rate being adjusted. Stated not much to work with, no other options, the auditors reviewed the proposal and were in concurrence.

Board Member, D. Breeding – Asked the status on the grants with Andy Miles.

Town Manager, G. Jones – Responded he is researching it and not sure where we are at with it right now. He explained about having Rural Water do a smoke test to possibly lower the PSA bill.

Chairman/Council Member, R. Cassell – Disccused PSA doing a sewer line down Daniel Boone Road with possibility of tying in with our line, explained PSA wanting Town to apply for the application first and possibility have Dan Danko come to meeting to see if we can work together to get that line repaired.

Board Member, D. Hartsock – Questioned repairing the line at the creek.

Chairman/Council Member, R. Cassell – Responded the worst line is running at the Vocational School at the creek and Andy's idea was to move the line to the highway to get it out of the creek. He asked about a Public Hearing for a rate increase with no meeting for Sanitation Board on June 19, 2013.

Town Manager, G. Jones – Explains the Public Hearing process with it needing to be held two weeks from tonight.
