# 3. Hire full time Public Works Employee - SA Liability Increase

Town Manager Greg Jones stated that the Town Council has approved hiring three full-time positions. The Safety Coordinator position will be merged into a Interim Public Works Director and hire two additional town crew team members. The part-time positions will be eliminated. The Sanitation Authority will be responsible for one full-time position and the town will be responsible for the 2<sup>nd</sup> full-time position and the Interim Public Works Director. The additional charge to the Sanitation Authority for the full-time position will be \$29,338.41. Greg Jones stated that the Sanitation Authority had \$85,000 in surplus for this year's budget.
